# What is a Quality System Standard (QSS)?


A document that establishes the requirements for a quality management system

A quality management system (QMS) is a set of policies, processes, procedures and responsibilities for achieving quality policy and objectives.

Quality System Standards for Testing establish the policies, procedures and responsibilities for ensuring that data derived from testing activities are:

Reliable, Relevant & Adequate *for*Intended Use


# The Umbrella Metaphor




# **Problem with the Umbrella Metaphor**

## **General Comparison of GLP and ISO/IEC 17025**

### **GLP**

#### REGULATORY STANDARD

- Often Written into Law
- Any Industry
- Specific Application
- Emphasizes Individual Study
- No Accreditation

# **ISO/IEC 17025**

#### **COMPETENCY STANDARD**

- Voluntary or Mandated
- Testing & Calibration Laboratories
- Broad Application
- Emphasizes Management Systems
- Non-Government Body Accreditation

# **Good Laboratory Practices (GLP) Applications**

## **OECD GLP**

- International & Intergovernmental
- More Flexible
- Consensus Based Guidance

## **USA GLP**

- US Regulatory (FDA & EPA)
- More Prescriptive
- Regulatory Interpretation (FAQ)

# **GLP: Which Application Should I Use?**


# What is the purpose of your study? Where will the data be submitted?

**OECD:** Principles applied to non-clinical safety testing of test items contained in pharmaceutical, pesticide and cosmetic products, veterinary drugs including food and feed additives and industrial chemicals. (International)

**FDA:** Prescribed practices for conducting non-clinical laboratory studies that support or are intended to support applications for research and marketing permits for products regulated by the Food and Drug Administration to assurance quality and integrity of safety data filed under the Federal Food Drug and Cosmetic Act and the Public Health Service Act.

**EPA:** Prescribed practices for conducting studies relating to health effects, environmental effects and chemical fate testing to ensure quality and integrity of data submitted pursuant to testing agreements and rules under the Toxic Substances Act (TSCA).

# **Quality System Standards - The Family Tree**



#### **TNI Standard**

- Accreditation Standard Mandated or Voluntary
- Incorporates Full Text of IS0/IEC 17025
- Includes clarifying language and additional requirements
- Developed by Consensus
- Widely Recognized and Accepted in Environmental Testing Community

#### **NELAP:**

National Environmental Laboratory Accreditation Program

#### **NEFAP:**

National Environmental Field Accreditation Program

# **Quality System Standards – Department of Defense**

## DoD Consolidated Quality System Manual (DoD QSM)

- AFCEE (Air Force Center for Environmental Excellence)
- NFESC (Naval Facilities Engineering Service Center)
- USACE (US Army Corps of Engineers)
- DOE (Department of Energy)

Based on ISO/IEC 17025:2005 & TNI Standard Volume 1 Includes additional definition and requirements specific to DoD objectives


